5. Planning Applications

Proposal: Demolition of existing conservatory and erection of new garden room. Location: The Paddocks Tolleys Lane Chaffcombe Chard Somerset TA20 4AA Application Number: 24/01266/HOU

Chaffcombe Parish Council considered the above application and had no objections to the proposal.

6. Highway matters

6.1 New passing place at the top of Knapps Lane

The Golf Club have agreed to put the gates for the new storage building at the top of Knapps Lane further back so as to provide a much needed passing place.

6.2 Extra passing places

A resident has asked if it would be possible to provide another passing place at this section of Knapps Lane because it can be difficult if a motorist is caught at the S bend of the road. And whether the entrance to the gateway at the bend could be improved to make it easier during wet weather.

6.3 Money donated for work on the drains in Knapps Lane

Several years ago £1,000 was donated for flood relief work on the drains in Knapps Lane. So far only £200 has been spent to reinforce a gulley to improve drainage. The donor has requested the money be returned to him because it has not been spent. Councillors agreed to return the £800.

6.4 <u>Temporary barrier at the bridge</u>

The Clerk was asked to chase Highways again to see when the work will be done.

Chaffcombe's PPLO will not be walking the footpaths for a while. The stile at Walscombe Cottages has been reported to Somerset Council Rights of Way.

8. Flooding

Cllr Bracher reported that the attenuation pond was completed a couple of months ago and the current systems all seem to be working well. It has yet to be tested with a lot of water.

9. LCN Meetings

Cllr Bracher went to the recent LCN meeting which was arranged for people in the water catchment area to discuss flooding. Chaffcombe is more forward on this matter because of the relationship with FWAG and the completion of the attenuation pond. The meeting concentrated on resilience and response to emergencies. In the Donyatt area they are very concerned about the river and problems up-stream. Cllr Bracher agreed to be the key contact for flooding in this part of Somerset.
