#### 8. **Footpaths**

Chaffcombe's PPLO reported as follows:

"Monthly walks on the Chaffcombe Parish Council footpath network continue despite ground conditions being extremely wet.

The three large trees that fell down during recent storms and obstructed Whitemore Hill and the Lydmarsh track have been expertly cleared as well as a further tree on the track through Youngs Copse. The two sinkholes that appeared halfway down Whitemore Hill due to spring water and were full of glutinous mud have been filled by Cllr Bale, so thanks are due.

A walk last week noted that the handrail to the staircase off Knapps Lane on footpath CH4/13 leading to the stream has a rotten support post but I have not yet reported this to Rights of way as I believe work will be carried out within the village.

### 8.2 Insurance Provision for volunteers

The Clerk checked the Council's insurance policy and confirmed that it includes a £10 million public liability cover. This covers councillors and also volunteers provided they are working to carry out work agreed with the Parish Council and not work which has not been agreed. The Parish Council must be satisfied that the volunteers who are working for the Council are competent to do the work they are asked to do and must undertake a risk assessment. Contractors who are paid to do a job should have their own insurance.

# 9. Flooding

## 9.1 Village Hall

During the recent storm the Village Hall was flooded for the first time. Water came from the road and flooded the car park and the Hall. Cllr Bracher was going to speak to FWAG for a professional opinion on the best way to prevent this in the future. One possible solution is to cut holes in the back wall for the water to escape. There is a grant for flooding works but this must be applied for by 25th February so time is short to have a project costed in time for an application to be made. It was felt that these grants will probably be available again in the future.

### 9.2 Drain

Some flooding was caused by a blocked drain underground. Cllr Wills will contact Highways.
